## Nordic ministers for gender equality met in Reykjavik



At their meeting in Reykjavik on 26 September, the Nordic ministers for gender equality decided to continue their efforts within the framework of "Pushing back the push-back". The ministers for gender equality will continue to "push back" resistance to gender equality around the world. This includes working with Nordic embassies in selected countries to promote the rights of women and LGBTI people. The ministers are also launching a study on masculinity and men's attitudes to gender equality in the Nordic Region.

- "It's extremely important to continue the fight against the backlash on gender equality and LGBTI rights. We have a long and prosperous history of Nordic co-operation on gender equality and LGBTI rights. We have a duty to contribute to the fight where the rights of women and LGBTI people are under threat," says Katrín Jakobsdóttir, Prime Minister and Minister for Gender Equality in Iceland, which holds presidency of the Nordic Council of Ministers this year.

## New report focuses on older LGBTI people

On behalf of the government, the Swedish National Board of Health and Welfare (Socialstyrelsen) has analysed how local authorities work with LGBTI people's need for health and social care. The survey shows that many older LGBTI people feel anxious about taking part in municipal health and social care, for example when they think about meeting health and social care staff in home care or nursing homes.

During the year, NIKK is also working on a project on the living conditions of older LGBTI people in the Nordic countries. The report will be published later in the autumn.
